This CPG was created by an international panel with expertise working with persons with EB. The CPG focuses on neonatal care using a systematic review methodology covering four key areas: (i) diagnosis and parental psychosocial support; (ii) hospital management: medical monitoring wound care and pain; (iii) feeding and nutrition; and (iv) discharge planning and EB education.
